CONDITIONS OF SETTLEMENT

1. The intending bidders will have to deposit the earnest money only in cash before actual commencement of the Auction Process.
2. All the bidders who will participate in the Auction occasion are compelled to call for a single time at least otherwise the earnest money deposited by him/them will be forfeited.
3. Each bidder will have to participate in the occasion physically and representative/relative of under age of any bidder will be allowed by no means.
4. The lease amount of Auction is imposed as early lease value/Revenue of the pond..
5. The considered highest bidder will have to pay the total bid amount in cash repeat in cash only on the same day in place of public auction i.e. in the office chamber of the Savapati, Amta-I Panchyat Samity, Amta, Howrah. Otherwise his bid will be treated as rejected and the deposited Earnest money will be forfeited and legal action will be taken up by this end against him.
6. The highest bidder and the bidders who stand in 2nd position and 3rd position will not be allowed to leave the Auction place till completion of total Auction process (including payment in cash of the total bid amount by the highest bidder).
7. **The Lease holder will be allowed for construction / erection of any permanent structure on any side over the banks of the pond by no means. He may be allowed only for erection of temporary structures for observation of the arable pond for the lease period.**
8. **The difference of amount between two consecutive calls must be Rs. 2000.00 (Rupees Two thousand) only in minimum.**
