The applicant in the same nature and type as prime contractor should have successfully completed at least one contract of same type of work at least 50% of similar nature of the work in a single contract within last 5 (five) financial years from the date of issue of this NIT in any Government / Semi Government/ Undertaking/ Autonomous Bodies / Statuary Bodies and Local Bodies who satisfy the terms and conditions set out in pre-qualification document and having registration in e-procurement portal.

Names of the Technically qualified bidders on the basis of information furnished in the check list and in "My document" uploaded by concerned bidders after verification of the same with original, will be displayed in the portal and this Office Notice Board, subject to completion of verification and technical evaluation.

In case if there be any objection regarding prequalifying the Agency that should be lodged to the Executive Officer, J.B.Pur P.S, Munshirhat, Howrah within 2 days from the date of publication of

st of qualified agencies and beyond that time schedule no objection will be entertained by the Executive Officer, J.B.Pur P.S.

If any document submitted by a bidder is either manufacture or false/fabricated, in such cases the eligibility of the bidder/tenderer will be out rightly rejected at any stage without any prejudice.

The Executive Officer, Jagatballavpur Panchayat Samity reserves the right to reject or cancel any or all prequalification documents and bid document without assigning any reason's whatsoever.

The eligibility criteria as stated in the standard Bidding document are given below:-

1. Achieved in any one year during last five years in the same name and style (excluding current year) a minimum financial turnover as certified by Chartered Accountant and at least 50% of which is from civil engineering construction works and equivalent to amount given below: (60% of amount put to Bid the turnover will be indexed at the rate of 8% for a year).
2. Credential certificate of successful completion of similar nature of work along with the copies of work order for works completed within last 5 (five) financial years of values not less than 50 % (Fifty Percent) of the works or including mentioning time of completion of work with payment certificate otherwise credential of works are in progress or payment certificate will not be entertained.
3. Income Tax return for last 3 years and up to date P Tax should be submitted.
4. Up-to-date Pan, GST Registration certificate, Income Tax, Professional Tax Clearance, Credential Certificate etc.(Xerox Copy) should be furnished.
5. Proposal for sub contracting is not allowed.
6. No conditional/incomplete tender will be accepted under any circumstances.
7. The intending Tenderers are required to quote the rate **on line**.
8. Formal agreement shall have to be executed by the lowest Tenderer.

The amount of earnest money is 2% of the estimated cost of construction.

All duties, taxes, royalties, cess, including 1% Cess under W.B. Building and other Construction Workers (Regulation of Employment & Condition of Service) Act, 1966, toll, Taxes and other levies payable by the Contractor under the Contract to the state/Central Government for any other cause, shall be included in the rates, prices and total Bid price submitted by the bidder. **1% Cess under W.B. Building and other construction workers (Regulation of Employments & condition of Service) welfare cess act, 1966 will be deducted from the running bills.**

Defect liability period for the said contract is 6 month from the date of completion. Any damages occurred during defect liability period will have to be done by the contractor at his own cost. If not done Security money will be forfeited.

The intending bidders are requested to inspect the proposed site before quoting their rates. The final payment will be made after availability of 2nd instalment.
