The certificate of experience and payment for the minimum criteria fixed as shown in point 4 above must be produced in original to the undersigned stating clearly the details of estimated work value (tendered amount of the work) with name and location of the work (title of the scheme), total amount of payment received against a complete single work (undertaken from financial year 2012-13 i.e. work order date is 01.04.2012 or later) of desired nature as detailed in the Annexure.

Necessary earnest money (detailed in the Annexure sheets) will have to be deposited in the form of Bank Draft drawn in favour of "**Executive Officer, Amta-I Panchayat Samity**" along with the tender document(s) and no tender will be accepted / considered without deposition of Earnest Money.

Application for purchasing of Tender Form will be received by this end **up to 12:00 noon on 12.02.2018** and the **Tender Forms** will be issued **up to 2:00 P.M. on same day i.e. 12.02.2018** to the **eligible** applicants only from accounts section of panchayat samity.

The tender documents available in the **TENDER BOX** will be **opened on the same day i.e. on 12.02.2018** at **4:15 P.M.** in presence of the intending and available bidders or their authorized representatives.

The rate should be quoted in figure and word and only once on over all percentage basis above / below / at par of the total amount put to tender. Double quoted rate / overwriting / different rates against different items of work will be treated as Informal Tender. Any change of the tendered rate in the tender paper during opening of tenders will be allowed by no means and anything is illegible will be treated as cancelled.

The undersigned reserves the right to reject any tender / all the tenders without assigning any reason . The undersigned is not bound to accept the lowest rate.

The deposited earnest money (@2% of work value) of the successful bidder to whom work order be issued will be returned back to him after completion of reasonable part of work on receiving application for the same certified by concerned SAE. 10% of the bill amount will be deducted from bills prepared by SAE as security deposit. Also, usual taxes applicable at the date of bill preparation for specific kind of work will be deducted from bill(s).

Before submission of the tender, the bidder must visit the work site to judge the local condition from all corners and no plea / complain about the work site will be entertained afterwards.

If the critical date [i.e. last date of application and (or) tender opening date] already mentioned be declared as Holiday, the tender process for the critical date will be performed on the next full working day up to the time already mentioned in critical date .

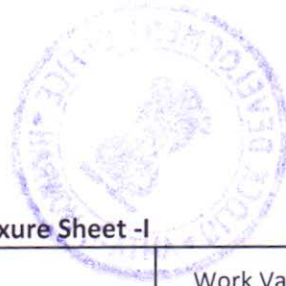


