**ORDERS**

Whereas the Block Level Screening Committees had recommended the applications, the **District Level Selection Committee** Chaired by the District Magistrate & Collector, Howrah in the **second phase**, had approved the names of the beneficiaries as given in attached sheet for implementation of FSSM and OTA-SFI scheme to the Marginal/ Small Farmers to purchase the Farm Implements at per approved rate of Govt. Subsidy in pursuance of the Memo no. 1478-Nab./2S-03/12 (Pt.I) dtd. 24/09/2018 and Memo no. 1661-Nab./2S-03/12 (Pt.I) dtd. 09/10/2018 of the Deptt. of Agriculture, Govt. of West Bengal.

Requisition of Fund for approximate requirement is placed to the State Hq. After receipt of Fund from the State Hq., the beneficiaries approved by the DLSC will purchase the Farm machineries as per approved list from **Authorised Dealer/ Vendor**.

Govt. Subsidy will be sent to the Beneficiary's Bank A/c directly through DBT mode by Treasury drawal / from District's bank A/c after submission of the following documents to the respective Assistant Director of Blocks.

6. Copy of the **DLSC Approved List**.
7. **Distribution Certificate** signed by **only authorised Dealer/ vendor**, respective **Beneficiary** and **Asstt DA** of Block in **Annexure-IX** format.
8. Copy of **GST Bill** signed by the Beneficiary, countersigned by Asstt. DA of Block.
9. **Beneficiary's bank details** ( A/c name, A/c number, Bank/ Branc, IFS Code)- signed by the Beneficiary, countersigned by Asstt. DA of Block (A/c should not be DORMANT A/c)
10. Copy of **Sanction Letter** to the respective beneficiary issued by Asstt DA of blocks for purchasing approved implement

The Asstt. DAs of Blocks are therefore instructed to **GO-AHEAD** for implementation of this scheme with **issuance of Sanction Letter** for individual beneficiaries. The beneficiary will in turn **purchase the approved machinery from the authorised vendor/ dealer in full price** and submit the above 05 documents to the respective Astt DA of Blocks for release of subsidy in their bank a/cs.


**For Treasury drawal**, the Govt. Subsidy will be transferred in DBT mode to the Bank a/c of the beneficiaries after receipt of fund from the State and **after submission of the above documents to the respective Asstt Dir. of Agriculture(Admn.) of Sub divisions through Asstt DA Blocks**.

**For NFSM fund**, the Asstt DA of blocks **will retain** the above 05 documents in their offices and they will submit the exact requisition of Fund stating that they had received the required documents from the beneficiaries.

**For release of Subsidy**, the **Beneficiaries have to purchase the machines from the authorised and portal enlisted vendor/ dealers only**.
