WHEREAS, clause(d) of section 2 of the Right Of Children to Free and Compulsory Education Act, 2009 (35 of 2009)(hereinafter referred to as the RTE Act, 2009) defines "child belonging to disadvantaged group" means a child belonging to the Scheduled Caste, the Scheduled Tribe, the socially and economically backward class or such other group having disadvantage owing to social, cultural, economical, geographical, linguistic, gender or such other factors as may be specified by the appropriate Government, by notification

AND

WHEREAS, the Hon'ble Supreme Court of India by its order dated 31/03/2017 in Writ Petition (Civil) No. 147/2014, NAZ FOUNDATION (INDIA) TRUST — Vs — U.O.I & ORS., has directed State Governments to include and to notify children living with or affected by HIV, as belonging to a disadvantaged group under section 2(d) of RTE Act, 2009.

THEREFORE, in consideration of the above, the Governor is pleased to include child living with or affected by HIV as "child belonging to disadvantaged group", as defined in clause (d) of section 2 of the said Act.
