**ORDER**

West Bengal Group-D Recruitment Examination Board is going to conduct recruitment examination to the post of Group-D for different Govt. Offices on 20.05.2017. In our district 159216 nos. candidates will appear for written examination in 327 venues.

For smooth conduct of the examination following officers are engaged as PS Coordinator and Supervising Officer. As Officer-in-Charge of all police stations have been declared as custodian of question papers, all plan and program will be prepared police station wise.

As per discussion with the Commissioner of Police, Howrah Police Commissionerate and the Superintendent of Police, Howrah Rural Police, it has been decided that question papers will move to venues and answer scripts will move to police station sector wise. All venues in a police station area will be distributed in some number of sectors so that all venues within a sector get question papers by 1.00-1.30 hours from time of dispatch from police station.

PS Coordinators and Supervising Officers will have to perform various other jobs which will be communicated to them in training on a convenient day.

For the time being PS Coordinator and Supervising Officers are directed to prepare sector plan in consultation with the concerned Officer-in-Charge of the police station and submit the same by 02.05.2017.
