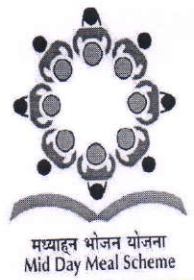

The cooking cost has been revised with effect from 1.01.2019 vide no. 44(26)-ES/CMDMP/Genl-11/2011 dated 14.02.2019 of School Education Department (Mid-Day-Meal Section) as,

An amount of Rs. **5,47,46,439.00 (Rupees Five crore Forty Seven lakh Forty Six Thousand Four Hundred Thirty Nine)** only was sub-allotted vide no. 48 MDM/How dated 7.02.19 in the old rate.

Now, an amount of Rs. **40,38,468.00 (Rupees forty lakh thirty eight thousand four hundred sixty Eight)** only is sub-allotted as arrear cooking cost for the period from January'19 to March'19 to all 14 Blocks (Amta-I, Amta-II, Bagnan-I, Bagnan-II, Bally Jagacha, Domjur, Jagatballavpur, Panchla, Shyampur-I, Shyampur-II, Sankrail, Uluberia-I, Uluberia-II, Udaynarayanpur) & Uluberia Municipality.

The Secretary of the VEC & WEC of the Primary schools & MC of Upper Primary Schools will exercise supervision over the entire feeding process.

A copy of an account of expenditure in respect of the amount sanctioned herein should be collected by the Chairman, Uluberia Municipality, Block Development Officers for all schools within their area on monthly & quarterly basis.

Utilization Certificate in proper format must be submitted by the Block Development Officers within **end of 4th Quarter** after actual utilization of sub-allotted fund.
